4.2	The general principles in the Bill and the legislative process were reported. The Coleg's overall position on the Bill was outlined. It was reported that the Chief Executive and the Senior Manager for Language Skills and Workforce Planning would give oral evidence before the Children, Young People and Education Committee on 17 October.		
	At this point Iwan Evans, Lucy Evans, Alan Jones and Bethan Webb, Welsh Government officials joined the meeting and were welcomed.		

4.3	Bethan Webb gave a presentation on the Welsh Language and Education Bill including the timetable.	
4.4	The Board members asked several questions.	
4.5	During the discussion the Coleg's support for the Bill was noted. Clarity was sought on whether or not the National Framework in the Bill covers tertiary education, and the Coleg's view that it should be covered was noted. In addition, the need to define the difference between learning Welsh as a second language, learning through the medium of Welsh and Welsh as a subject was noted.	
	Government officials were thanked for the presentation before they departed. At this point Professor Enlli Thomas also left the meeting.
